Privacy Policy

This Privacy Policy describes how we manage, process and deal with your personal information that we have collected, received, obtained from you through Our Services to You. Personal information collection

Purposes/Use

Your personal information with Us will be use:

Your Rights

- e) To withdraw Your consent to Us.

Retention/Erasure We retain Your personal information only for as long as necessary to fulfill the stated

purposes unless it is required by law for a different period or We have obtained consent from You. We will periodically erase the personal information that is no longer needed.
